Butte County Association of Governments Transportation Advisory Committee Draft Summary Meeting Minutes for May 6, 2021

The following minutes are a summary of the Transportation Advisory Committee. The Transportation Advisory Committee Meeting of the Butte County Association of Governments was held at the BCAG offices located at 326 Huss Drive Suite 150 in Chico. The meeting started at 10:00 a.m. via zoom.

Item #3 - April 1, 2021 TAC Meeting

No comments were received.

Item #4 – 2021 Federal Transportation Improvement Program Amendment #03

Staff informed the committee of Amendment #03 to the 2021 FTIP. The purpose of the amendment was to make the following changes:

1. Autry Lane, Monte Vista & Lower Wyandotte Safe Routes to Schools Gap Closure Project.

The purpose of this amendment was to add additional scope to the original Autry Lane & Monte Vista Safe Routes to Schools Gap Closure Project by adding Lower Wyandotte to the scope of improvements. This amendment combined a previous Lower Wyandotte Bicycle and Pedestrian Project from the 2019 FTIP into the Autry Lane & Monte Vista project currently programmed in the 2021 FTIP. This project is located in South Oroville in Butte County.

2. City of Chico: Hegan Lane Business Park Access Improvements Project. The purpose of this

amendment was to change the fund source from Local Advance Construction funds to Congestion Mitigation and Air Quality Program (CMAQ) funds for \$391,373. The overall costs and project delivery schedule did not change.

Staff informed the committee that BCAG is required to report FTIP amendments to the committee in accordance with its Public Participation Plan procedures. This item was provided for the committee's awareness.

Item #5 - Senate Bill 743 Implementation Study - Update

Staff provided an overview of the SB 743 Implementation Study indicating that a complete document would be available for review later in May. In addition, staff indicated that final acceptance of the study would be presented to the BCAG Board on June 24, 2021. Staff stated that on April 22nd, a third and final stakeholder meeting was held in which BCAG's consultant team reviewed the VMT Mitigation Strategy and Local Plan and Policy Improvement sections.

In addition, the consultant team provided an overview of the VMT screening tool developed as part of the study. Staff emphasized that it is up to each local jurisdiction (lead agency) to develop its own methodologies and thresholds to meet CEQA transportation analysis requirements for land use projects and plans approved by their agency. All material is posted online at BCAG's website for the locals to utilize.

Item #6 - 2021/22 BCAG Overall Work Program and Budget

Staff informed the committee that the BCAG Board of Directors approved the 20/21 Overall Work Program (OWP) and Budget at their March 25th Board meeting. Staff indicated that the OWP identifies BCAG's state, federal, and local transportation planning responsibilities to be undertaken for the upcoming fiscal year. The specific work elements were included as part of the memorandum. This item was presented for information.

Item #7 - Chico to Sacramento Inter-City Strategic Plan Update

BCAG's consultant team LSC and Arup provided a presentation on the study efforts underway. The presentation included a brief overview of the study objectives, survey and data concerning the project. The Study is a partnership with BCAG, Caltrans and the San Joaquin Joint Powers Authority (San Joaquin Amtrak trains). The plan is to identify interregional transit connections between Butte County and downtown Sacramento to integrate service with B-Line, the Amtrak San Joaquin and Amtrak Capitol Corridor. This presentation was to keep the committee informed. As the study progresses, additional presentations to the committee will be held.

Item #8 - Caltrans Planning and Local Assistance Updates

Caltrans provided the committee with updates on:

- ATP Cycle 6 Scheduled for Spring of 2022. Projects not successful for Cycle 5 were encouraged to have a debrief with CTC staff.
- HSIP Cycle 11 for FY 22/23. A Local Road Safety Plan is required.
- DBE FFY 21/22. Compliance notification letters have been sent to local agencies
- Office Staff Changes: James Day provided an updated contact list for Local Assistance staff.
- Training LTAP training information was presented including new Local Assistance forms
- Inactive List James Day provided an inactive list for local Butte County projects and encouraged implementing agencies to submit an invoice.

CHICO TO SACRAMENTO PLAN UPDATE

PREPARED BY: Sara Cain, Associate Senior Planner

ISSUE: BCAG staff is presenting an update on the Chico to Sacramento Plan for the TAC's information.

DISCUSSION: BCAG is preparing the Chico to Sacramento Inter-City Transit Strategic Plan to provide the framework to integrate Butte Regional Transit (B-Line) and the San Joaquin Joint Powers Authority (SJJPA) Route 3 thruway bus (Stockton-Sacramento-Chico-Redding) to a consolidated commuter bus route.

The purpose of the study is to identify solutions to provide a regionally significant intercity connection between Chico and Sacramento by analyzing routing and timing plans, operating and capital costs, fare structure, park and ride opportunities, number and types of buses required, and develop a marketing plan.

BCAG staff and its consultant, Arup, will provide a presentation to the TAC on the Service Plan, which summarizes the following as it relates to the proposed service:

- Travel market and ridership assessment: Approximately 450-500 daily weekday one-way passenger trips are anticipated to occur between Butte County and Sacramento.
- **Public outreach:** Presentations to this committee, BCAG's Planning Directors Group, and other stakeholders along the corridor indicated there is a viable market opportunity for the service post-COVID.
- Fare structure and pricing plan: The analysis proposes a zone-based fare structure and pricing plan with free fare options per-mile including standard, discount, and monthly passes.
- **Proposed route:** The service would operate along SR-99 and SR-70 from Chico to Sacramento with some busses terminating in Stockton.
- **Proposed service schedule:** There would be nine trips in each direction on weekdays and eight trips on weekends to connect with Amtrak trains that would maximize ridership.
- Revenue and operating cost assessment: The analysis shows fare revenue would fall slightly short of anticipated operating costs, so BCAG would need to identify additional funding sources should the service be implemented.

2022 REGIONAL TRANSPORTATION IMPROVEMENT PROGRAM (RTIP) DEVELOPMENT

ISSUE: BCAG is required to prepare and adopt a Regional Transportation Improvement Program (RTIP) by December 15, 2021 for the 2022 State TransportationImprovement Program (STIP).

DISCUSSION: The purpose of the RTIP is to identify programming recommendations for the State Transportation Improvement Program (STIP). The STIP is adopted by the California Transportation Commission (CTC) and is comprised of two components including the Regional Improvement Program and Interregional Improvement Program:

STIP Components:

- 75% <u>Regional Improvement Program (RIP)</u>. Projects nominated by the Regional Transportation Planning Agencies (RTPAs) like BCAG as part of the Regional Transportation Improvement Program (RTIP Document)
- 2) 25% <u>Interregional Improvement Program (IIP)</u>. Projects nominated by Caltransas part of their Interregional Transportation Improvement Program (ITIP).

<u>Funding</u>

Every two years, Caltrans prepares a "Fund Estimate" (FE) identifying the amount of funding available to regions for new projects. For this STIP Fund Estimate, the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA) provided additional funding to California for transportation purposes. The STIP Regional Improvement Program and CRRSAA are shown as follows:

• STIP/RIP: \$10,444,000 Delivery under STIP guidelines

• CRSAA (STIP) \$1,262,252 Delivery through CRRSAA/STIP guidelines

• CRRSAA (Non-STIP) \$1,061,606 Delivery through CRRSAA/STIP guidelines

\$12,767,858 Total through FY 26/27 to Butte County

Requirement for ALL Projects

BCAG has identified 4 requirements for new project programming consideration. These requirements are consistent with STIP guidelines.

- Regional Transportation Plan/Sustainable Communities Strategy All projects are required to be included in the current 2020 Regional TransportationPlan/Sustainable Communities Strategy (RTP/SCS).
- Project Study Reports A complete project study report (PSR) or, for a project that is not on a State highway, a PSR equivalent. Posted guidance can be found here: https://catc.ca.gov/-/media/ctc-media/documents/programs/stip/stip-psr-guidelines-a11y.pdf.
- Criteria for Measuring Performance and Cost-Effectiveness Depending on project, some level of performance metric demonstration is required. The project level benefit evaluation is listed in the STIP guidelines and posted at:
 http://www.bcag.org/Planning/RTIP/index.html. The criterion in the guidelines aims to capture; VMT reductions, air quality benefits, mode shift, distance to transit service and safety benefits as relevant to the project.
- ePPR Electronic Project Programming Request form is required. Guidance is posted at: https://dot.ca.gov/-/media/dot-media/programs/financial-programming/documents/eppr-instructions-v101-a11y.pdf. The ePPR will be posted at http://www.bcag.org/Planning/RTIP/index.html. The ePPR is a similar spreadsheet in XL as is used for FTIP projects.

BCAG Project Criteria Evaluation

BCAG is developing project evaluation criteria that is consistent with the goals of the Climate Action Plan for Transportation Infrastructure (CAPTI) built from the Governors Executive Orders (EO) EO N-19-19 and N-79-20. These Executive Orders and the CAPTI are expected to become the basis for which ALL transportation funding is delivered. Additionally, BCAG must report progress on "Federal Performance Measures for PM 1, 2, 3 & Transit" to FHWA and to CARB under SB 375 for achieved GHG reductions.

In an effort to meet the various existing and impending guidelines, programs and reporting, RTIP project evaluation criteria are expected to focus on:

- GHG reduction
- VMT reduction
- Development and integration of public transit with multimodal rail, bicycle and pedestrian infrastructure
- Significant expansion of equitable transportation opportunities to underserved communities
- Safety
