**Meeting Summary**

City/County/Agency GIS Programs

Chico State –

- New fuels mapping project for Madrone Lake
- Continued to assist Paradise Parks and Recreation District with trails mapping.
- Continue project with the City of Chico to update right-of-way data.

City of Chico –

- Enterprise GIS installation expected to be completed January 2024
- Right-of-Way layer is nearing completion. 6-month project

CalFire –

- Continued work to complete Fire Hazard Severity Zones.
- State Responsibility Areas are set for Spring 2024.
- Recently completed Direct Protection Areas maps for region.
- Currently looking into creating consolidated fire hydrant inventory.
- Continued coordination of evacuation zones with Sheriff's office.

City of Oroville –

- Working on coordinating GIS services with Butte County GIS Division

Butte County Public Works –

- Migrating to ArcGIS Pro
- Digitizing old maps of County assets
- Working to develop map of construction schedule
- Assisting Public Health with GIS needs

Butte County Resource Conservation District –

- The RCD has grown to 8 staff
- Working on establishing local contacts for a countywide Forest Health Map project

Butte Fire Safe Council –

- Council now has 3 GIS staff members
- Currently integrating Field Maps for fuels reduction projects
- Transitioning to ArcGIS Pro
- Working on a solution for tracking projects with APN's

BCAG –

- Integrating CA Dept of Housing and Community Development (HCD) residential construction data into annual updates process
- Continued work on Land Use Allocation model for 2024 Regional Transportation Plan
