City/County/Agency GIS Programs

Chico State –

- Continued data maintenance and support for BCAG
- Paradise Park & Recreation District trail mapping
- Providing GIS support for surrounding counties (Tehama and Siskiyou)
- Cole Morales (Tribal Liaison) provided update via email work to understand GIS Tribal priorities will begin this fall.

City of Chico –

- City staff attended ESRI conference in July
- Beginning to collect data regarding fiber optic line locations
- Utilizing Portal access for main data storage

Butte County GIS Division –

- Staff has been pulled from normal duties to staff emergency services for Thompson and Park fires
 - o Utilizing Survey 1-2-3 for site inspections
 - o Maintaining Evacuation zones live map
 - o ESRI has aided
- Annexation dataset is behind schedule due to emergency duties

Butte County Public Works -

- Transitioned to fire season
 - O Using Survey 1-2-3 in field to evaluate assets
 - Mapping to assist animal disaster groups locate properties

Town of Paradise –

- Getting GIS software and datasets up and running
- Chico State aiding with datasets
- Identifying a Right-of-Way layer
- Collecting old as-built data from County
- Identifying a recorded maps workflow

CalFire –

- Pre-planning work with County staff has helped during emergency
- Park fire datasets can be accessed via ftp.wildfire.gov
- Local Response Areas update still in-progress and estimated complete in 12 months. A new assembly bill looks to dissolve zones.
- Community Wildfire Protection Plan update is still in-progress, reach out to fire safe council or CalFire to include projects
- Possible funding to add pre-planning staff

BCAG -

- On-going annual regional datasets update with Chico State
- Working on tracking of local development projects
- Continued work on Land Use Allocation model for 2024 Regional Transportation Plan
