RE: Review of Adopted Regional Housing Need Allocation (RHNA) Plan

Thank you for submitting the Regional Housing Needs Plan that the Butte County Association of Governments (BCAG) adopted April 24, 2008 which was received on May 8, 2008. As you are aware, pursuant to Government Code Section 65584.05(h), the Department is required to review RHNA plans and may make revisions for consistency with statutory requirements.

The Department is pleased to find that the adopted RHNA plan addresses the total housing need of 13,944 units (Table 10, Page 12) which is consistent with the Department's August 30, 2007 Regional Housing Need Determination total. However, please note that the Department made technical revisions to the income category allocations in Table 10 (refer to Attachment 1 and explanation that follows) which require BCAG to make an errata change to its plan and ensure each jurisdiction is informed of the technical adjustments made by HCD as a condition in approving BCAG's Final Plan. Please provide the Department documentation of follow-up action taken by BCAG.

The Department made technical adjustments to each income category allocation to ensure income category totals are consistent with the Department's determination by income category. The discussion between Glen Campora, of our staff, and Brian Lasagna, of your staff, indicated slight differences occurred due to using different rounding conventions regarding income category percentages.

The Department is committed to working with BCAG and your local government members to effectively address the region's housing and community development needs through the housing element update process and other related planning and assistance efforts.
